Your file is closed upon graduation or termination from the program. As required by law, the program is responsible for tracking academic performance of our participants until graduation or termination of a college or training program. Student records are kept for a period of eight years, and academic tracking records are maintained as long as you are pursing college or training. Furthermore, I authorize VUB to collect information from third party(ies) regarding previous academic performance and proof of military service such as colleges/universities, Veterans Affairs offices and other VA related facilities on my behalf.
